Minutes of Meeting of Board of Governors/Management meeting held on Saturday the 01st Nov 2025 in the Board Room, Behara College of Engineering and Technology, Narava at 10.30am and the Resolutions brought forth

1. To brief the board about the status of approvals from the AICTE, AISHE, APSCHE, and JNTUGV
2. Resolution has been taken by the society for the changes in the sanctioned intake as CSE 120 MEC 60 EEE 60
3. The member secretary informed the Board of Governors that the college was approved for in June 2025 for under-graduate courses i.e., Electrical, Electronics, Mechanical, Computer Science and Data Science Engineering courses and paid an amount of Rs. Lakhs FD towards the fee for approval from AICTE, Council Code from APSCHE and Affiliation from JNTU, Gurajada, Vizianagaram
4. To brief the board about the Startup of B.Tech Courses and admissions
It is informed that B.Tech engineering courses are started in Electrical, Electronics, Mechanical, Computer Science and Data Science Engineering courses with a sanctioned student intake of 30, 60, 30, 180 and 60 respectively for the AY 2024-25. The college has got approval from state government for second counselling. The recorded admitted admissions are ECE-20, CSD-5, ME-7, EEE-2, CSE-101 and a total of 137.
5. To brief the board about the established labs and to be established labs as per new R23 academic Guidelines of University
It is informed that the labs for first year of all engineering courses are established and equipped with high quality infrastructure to perform the labs as per R23 university academic regulations. And request proposals for establishment of new labs for second year are made with Lab suppliers.
6. To brief the board about the establishment of committees
It is informed that the committees as displayed in the college website are established for Internal Quality Assurance cell, Exam cell, Training and Placement cell, Research and Development cell, Internal Complaint Cell, SC/ST cell, Women Grievance, Redressal and Empowerment cell, Entrepreneur Development cell, Industry-Institute Interaction cell, Institution Innovation cell, and Anti-Ragging cell and appointed the co-ordinators for performing the objectives of committees and record the minutes of the meeting held as per schedule.
7. To brief the board about the staff and students performances
It is informed that six staff members are registered for Ph.D. programme in JNTUGV and Skill University for the academic year 2024-25 and CSE Staff, pursuing Ph.D. from GITAM University has published a TWO technical paper in the journal and at the verge of completion. An Asst. Professor from BSH has authored and published the text book on Mathematics. A senior staff has been appointed as a chief examiner at university exam section.
Students have performed well and stood runner-up in the District Youth Level competitions organized by Nehru YuvaKendra. Also participated and bagged prizes in the inter college competitions organized by Gonna Institute of Engineering and Technology.
8. To brief the board about the details of payments made to the University
Informed the members of board about the Details of payment have been made to the university for academic year 2024-25

Furnished the details of teaching and non-teaching staff those were appointed as per AICTE and university guidelines. These faculty are to be ratified as and the notification from the affiliated university.

18. Industry interaction programmes planned for the academic year 2025-26 were presented for approval, focusing on skill development and employability.
19. Overall student academic performance, including internal assessments and university examinations, was reviewed.

19. Various academic support activities and co-curricular initiatives conducted for student development were discussed.
20. The progress of Research and Development activities was reviewed, including publications, proposals, and future research plans.
21. Proposed future academic initiatives and institutional development plans were presented for consideration and approval.
22. The activities conducted under the National Service Scheme (NSS) during the academic year were reviewed, highlighting student participation and community outreach programmes.

26. Training and Placement activities, including Campus Recruitment Training (CRT) and Soft Skills development programmes, were presented for review and approval.
27. Faculty Development Programmes (FDPs) and workshops conducted for skill enhancement and academic improvement were discussed.

The member secretary briefed the Board of Governors about the MOU signed with AMTZ Visakhapatnam, Braino Vision, Teckybot, ExcelR, CSC Academy, MSSquare Technologies, and The Skill Shop for implementing skill development programs, hands on experience workshops, Faculty Development programs, student Internships and short term training programs.
